



# **INTRODUCTION** of AJOU GSIS

The Graduate School of International Studies at Ajou University was established in 1996 as a pioneer of professional studies programs in Korea. The founding motivation of Ajou GSIS was to meet the growing global demand of international academic institute. At present, Ajou GSIS has over 1,400 alumni students in more than 80 countries worldwide, who play important roles at their respective positions in government agencies and global enterprises. It is Ajou GSIS's main role to educate the future leaders professionally and academically for this increasingly complex global society, while also encouraging students to explore the very best out of their time and providing opportunities to discover their talents as a global leader.

Ajou GSIS currently offers four different departments with the courses that are applicable in the real international fields; International Business, International Trade, International Development and Cooperation and Civil Society Studies. Also since 2004, Ajou GSIS has been funded by KOICA (Korea International Cooperation Agency) to educate government officials from developing countries in international business, international trade, NGO studies, international development and cooperation, energy studies and civil society studies.

#### The Most Diverse International Student Population

More than 80 nationalities are represented at Ajou GSIS, including students from Asia, Oceania, Europe, Africa and America(North/Central/South). Ajou University maintains the highest foreign student enrollment in Korea. The university's increasing diversity is the most important and enduring asset of the Graduate School of International Studies.

Or, applicants should have an equivalent qualification to a Bachelor's degree which is approved by the Ministry of Education of their respective countries.

- \* GSIS strongly recommends that all applicants submit their Online Application Form before the deadline of the 1st or 2nd round of admission.
- \* Chinese students SHOULD send all their documents by the deadline of the 1st round of admission due to visa matter.
- \* Students who cannot come before the Orientation date should clearly inform the GSIS office of their expected arrival date via email. GSIS Admission will be withdrawn when students DO NOT come to the university 2 weeks after the semester begins.
- \* All documents submitted by the applicant will not be returned under any circumstances.
- \* Regardless of whether it is before or after admission, if it is confirmed that the applicant was accepted through fraudulent methods such as falsification or alteration of submitted documents, failure to meet eligibility requirements, or taking exams by proxy, their acceptance and admission will be canceled. In such cases, the tuition fees paid will not be refunded.

  - 1. A passport-sized photo (plain background)
  - 2. A copy of passport
  - 3. A copy of Alien Registration Card (only for Korean Residents)
  - 4. English Proficiency Test Score
    - \* Official Test of English as a foreign Language(TOEFL) or International Language Testing System(IELTS) or Equivalent English Proficiency Test Score
    - \* Above TOEFL-IBT 80, IELTS 5.5
    - \* Students from the countries where the official language is English should submit the Certificate that shows the medium of language was English in the undergraduate program.
  - 5. Statement of Purpose (SOP)
    - \* During the online application process, you will be requested to fill out the SOP form. (Minimum 500 words and maximum 2000 words.)

  - \* All documents necessary for admission application should be provided with original documents via post.
  - \* When original documents are written in a language other than English, applicants should submit the notarized and English translated version.
  - \* All the documents are non-returnable.
  - 1. Undergraduate Diploma or Graduation Certificate
  - \* Should be notarized by the Korean Embassy. In apostille countries, applicants should get apostille.
  - 2. Official Transcript of all undergraduate work
    - \* Should be notarized by the Korean Embassy. In apostille countries, applicants should get apostille.
    - \* When there is no explanation of the university's grading system on the transcript, explanation of one's home university's grading system should be included along with the transcript.
  - [GSIS Form] Two letters of recommendation from professors at an undergraduate institute or supervisors
    - \* At least one letter must come from a professor of your undergraduate institute
  - 4. One original copy of Verification of Deposit(VOD) of the person responsible for students' expenses (only under applicant OR parents' name)
    - \* The minimum amount needed for a student visa for a degree: KRW 20 million(20,000,000 won) in the deposit / Personal account only(VOD of the corporate is not acceptable)
  - **5. Relationship Certificate** (only when the VOD is in the name of the applicant's parents)
  - **6. Certificate of Income** (only when the VOD is in the name of the applicant's parents)
  - 7. [GSIS Form] Agreement form for Academic Verification
    - \* Print out the Form and send it with applicant's signature
  - 8. Application fee of USD 100 payment receipt
    - \* When the payment is made in KRW, please pay KRW 100,000.
    - \* Please remember that your admission process will only begin after the payment.

The dormitory at Ajou University accommodates 2,400 students in four modern buildings. International graduate students are normally placed at Hwahong hall and New international dormitory.
